TheGeneralBodymaymeet,inconferenceorotherwiseasandwhennecessary,butshallmeet atleastonceayear.Fifteendays'noticewillbeissuedbythesecretaryeitherbypostor throughdisplayon the institutionwebsiteorthroughanyelectronicmeans.

TheGeneralBodyshallbethesupremeBody.AllmemberscanparticipateintheGeneralBodyMeeting.It shallbeheldatleastonceayear,totakefinalapprovals,to pass thebudget andauditreports,totakeapprovalsfornewprogramsintheinterestoftheAssociation,ifneeded, toformsubcommittees,tohelp the GoverningBodyintheWorkingoftheAssociation,toamend theconstitution,andmanagealltheaffairsoftheassociation.

The Executive Committee will prepare a Plan of Action and required Budget (Income and Expenditure)everyyearandgettheapprovalfromt he GeneralBodyint he AnnualGeneral Meeting.

## 19. RULESREGARDINGLOANSORDEPOSITS

If need arises the Executive Committee is authorized to raise funds through TemporaryLoans andacceptingrefundableDepositsfrommembers.ExecutiveCommitteewillprepare Rules relating to acceptance of loans and deposits and get it approved from appropriate authorities.
20. PROVISIONS RELATING TO PURCHASE/ACQUISITION/SALE/DISPOSAL OFIMMOVABLE PROPERTY

The society shallpurchase/acquire/sell/disposeof anypropertyduring its existence asper the approval from the Governing body/appropriate authorities.

## 21. BANKACCOUNT

The Association shall open an account with a Nationalized/scheduled Co-Operative bank in the name of SNGC Alumni Association as approved by the Executive Committee. All funds/ donations will bedeposited into the said account which will be opened and Operated under the signature of the President or Secretary and Treasurer or Assistant Treasurer

No withdrawal from the association's account will be allowed without consent from the Executive Committee.
